

Standing Tee Times for the Period March 27- October 30, 2023
Application deadline is March 1, 2023

Lake Monticello golf club is pleased to provide standing tee times as a convenience to our golf contract holding members. It is our goal to offer this benefit to our golf contract holders while still maintaining maximum play opportunities for casual and outside players. Standing tee times may be reserved by groups of at least 4 players. Within each group, 3 of the 4 players (75% of the group) must be a current 2023 golf contract holder. To achieve this goal, managing the standing tee times requires coordination between the group and the golf pro through the pro-shop desk. From time to time some temporary adjustments might be needed and group flexibility is appreciated.

To facilitate this, we have established a few guidelines regarding standing tee times as follows:

- Each group must identify a primary and secondary point of contact who are current golf contract members.
- Each group must complete the application below and provide a roster of players on page 2. **If you are requesting times for multiple days, please use a separate request form for each day.**
- If a group does not consistently use the assigned times, the pro shop reserves the right to reduce or eliminate the group's standing tee time(s).
- Groups must notify the pro shop at least 48 hours prior if all reserved times will not be needed.
- If a group does not notify the pro shop of unneeded times in the 48-hour window twice, they will be warned. On the third time the groups standing times will be reduced.
- All released tee times become available for sale. Groups agree to give opportunity for players who purchase the tee time to begin play at their scheduled time.
- All Group players agree to register in the pro shop prior to play each day.
- All Group players understand that the cart fee is based on a single seat and agree to ride double. Group leaders agree to enforce this.
- The pro shop will provide play sheets for each group. Group representatives agree to return completed play sheets for each day. If no sheet is turned in, then the pro shop record of play counts is deemed accurate.
- **Standing times are reserved for groups with at least 4 players**

We agree to ask the pro shop to reduce the number of slots as soon as we discover that we do not regularly need them. We understand that if we fail to use the tee times on a reoccurring basis, the pro shop may reduce the number of slots or eliminate our standing status. We agree to be flexible when occasional changes are required. We also agree to update our roster as new players are added or deleted.
